Addendum to PD/OOD/14025

The Secretariat of the United Nations presents its compliments and wishes to provide additional information to all Permanent Missions regarding the ongoing vendor outreach in connection with the transition in solicitation methodology for the provision of air charter services (ref. PD/OOD/14025 dated 6 May 2014).

The letter attached to the NV was disseminated to the industry through various channels starting from 25 April 2014, with a deadline of 7 May 2014 for companies to express interest in the upcoming pilot RFP, and the UN Procurement Division (UNPD) received a significant number of responses by that date.

We appreciate that the note was sent to the Permanent Missions very close to the initial deadline and will accept late company responses up to Priday 16 May 2014, as the current project timelines allow us to do so. This is to ensure that such interested companies receive the solicitation document as soon as the tender is issued. However, the UNPD will also invite any late responder, as long as the timing is compatible with the company's participation in the mandatory proposers' conference scheduled for mid-June 2014.
