#### 1. General information:

The Organisation Pafos2017 European Capital of Culture is currently seeking bids from companies wishing to serve as Pafos2017 official Merchandise Suppliers to provide branded products (licensed items) for sale during the period......

Such branded products will promote the brand of Pafos2017 by bearing its registered Trademark as shown on the attached Schedule A, under the terms of a License Agreement to be agreed between the Parties.

The successful candidates will gain the opportunity, unless agreed otherwise, to develop and sell the approved official event merchandise and apparel for the Pafos2017 event during the above mentioned period. Further, the successful candidates will have the opportunity to display a link to the Pafos2017 website, on their own website as official licensees of Pafos2017.

Applicants must provide designs and samples of the merchandise, which are intended to be produced and distributed.

# 2. Responsibilities:

Any successful applicant will be expected to sign a licence agreement which will include (but not be limited to) the following terms and conditions:

- a. A complete description of the licensed merchandise in question
- b. License term: The non-exclusive agreement will be for a period of 2 years from ....... (with an option to extend for a further 12 months).
- c. The territory / geographic area of distribution
- d. The channels of trade which shops, stores the products are sold at.
- e. The applicant will be responsible for all costs of designing, producing, promoting, distributing and selling the material. Pafos2017 will not bear any of these costs.
- f. The applicant will comply with Pafos2017's Brand Guidelines and quality control including allowing the licensor the right to obtain random samples of merchandise during the term of agreement to confirm the quality.
- g. All material will require Pafos2017's approval (as regards its nature, form and content) before it is produced and distributed. In particular, the trademark cannot be accompanied by any other logo and or trademark and or slogan on the merchandise unless by special agreement mutually agreed between the parties.
- h. The License fee

- i. The Organisation Pafos2017 will have the right to request a limited amount of each item of merchandise, to be agreed between the parties, to be used for promotional purposes only.
- j. The payment schedule will include a non-refundable down payment (performance fee) of 30% of the license fee upon signing of the relevant license agreement. Further payment terms to be agreed.

#### 3. Categories of goods:

Items that will be considered including but not limited to:

#### Category 1 – Products for children

Soft toys, pencils, pencil cases with coloured pencils, colouring books, notepads, notebooks, and school bags.

#### Category 2 - Clothing

Baseball caps, swimming costumes for ladies and men, T-shirts, shorts, sportswear, scarves

Towels, mugs, Cyprus coffee sets, Coasters, Place mats, Fridge magnets.

#### Category 4 – Decorative / personal items

Key rings, paperweights, waist bag, wallets and purses, brooches or label pins, cufflinks and earrings.

#### 4. Process of Assessment and Award: (see Schedule B)

- 4.1 Pafos2017 will award the licences on the basis of:
  - a) Applicant's track record in designing, producing and distributing merchandise
  - b) Business plan: Distribution and marketing plan for before, during and up to the completion of the contract.
  - c) Responsiveness of supply chain ability to respond quickly from design to manufacture.
  - d) Evidence of quality and safety of merchandise.
  - e) License fee offered.
- 4.2 It is anticipated that a final decision on the selected company will be reached and communicated no later than 2 months from the submission date based on a review and selection process by the Pafos2017 Board of Directors.
- 4.3 Pafos2017 reserves the right to invite short list candidates to its board meeting to present and discuss the proposals further.

- 4. Evidence of quality and safety of merchandise.
- 5. License fee offered.

- Size of the business 3%
