Litro Gas Lanka Limited wishes to call for International Competitive Bids for the supply of 350,000 (+/- 10%) Metric Tons of Liquefied Petroleum Gas (LPG). The LPG requirement is evenly spread over a period of One Year commencing October 2018.

LPG should be supplied in ocean tankers, which will be required to be discharged at the Litro Gas Terminal Lanka (Pvt) Limited Conventional Buoy Mooring, located off the coast of Kerawalapitiya (7 km North of Colombo) Sri Lanka, or at the Port Discharge Facility of the Hambantota Port situated in the South of Sri Lanka.

All details pertaining to this Tender is clearly stated in the Bid Document. The said Bid Document may be obtained at the under mentioned address on the payment of a non-refundable fee of SLRs 25,000/= (or US\$ 200) on any working day (Monday – Friday) between 9.30 am - 3:00 pm from 15th May 2018 to 13th June 2018 (both days inclusive).
