Thirty-day e-visas for stays of up to eight days from the date of entry in the Kaliningrad Region are issued free of charge based on the online application by a foreign citizen on the Foreign Ministry's website no later than four calendar days before the scheduled arrival date. It must be accompanied by an e-file with an attached digital photo. No other documents are required to receive an e-visa.

E-visas for visits to the Kaliningrad Region within its territory are valid for entry into and exit from the Russian

Federation only through the state border checkpoints on the territory of the Kaliningrad Region.

Transport companies are able to check the possession of a valid e-visa by a foreign citizen on the Foreign Ministry's special automated website <https://evisacheck.kdmid.ru/>.

The Embassy requests Ministry's kind assistance in conveying the aforesaid information to the attention of the Ministry of the Interior, the Ministry of Transport, Communications and Works and other interested Ministries and Departments of the Republic of Cyprus.
