Therefore, the Government wishes to invite qualified Oil and Gas companies/consortiums for exploring oil and gas (the conventional and/or unconventional) resources in the open exploration contract areas.

**Qualification Criteria**

The qualification criteria will be applied to the company and all its partners, or consortium members collectively, provided that members do not change until all obligations have been fulfilled.

The Government is interested in working with qualified companies both financially and technically. The company/consortium will need to demonstrate a successful track record in exploration and production of hydrocarbon resources, conventional and/or unconventional.

**Qualification Criteria**

1. The lead company/consortium will need to be a registered company and submit the financial records for the past 3 years.
2. Newly formed companies/consortiums will need to submit evidence of their financial ability to conduct the exploration phase activities and raise finances for the development phase. Evidence is: paid up capital of at least \$2 M and a bank statement of at least \$5 M in cash to be dedicated for spending on initial exploration. Note that there will be spending guarantees later on should the company be selected for work.
3. Demonstrated technical expertise in exploration of conventional and/or unconventional oil and gas. List 2 exploration projects.
4. A capable technical team of at least 5 qualified members to lead this exploration. All of minimum expertise of 10 years.
5. No legal action taken against any of the partners due to negligence and excessive damages in the past 10 years.
6. No filings for bankruptcy in the past 10 years.

Qualified companies/consortiums will be invited to receive further tender documents in order to prepare and submit their exploration work plan to be evaluated by MEMR. Only companies with approved work plans will be eligible to sign a Memorandum of Understanding "MOU" as a first stage before negotiating a Production Sharing Agreement "PSA".
