High Level Virtual Event with the British-Indian Business Community
Tuesday, 15 June 2021

The Cyprus Chamber of Commerce and Industry and the Ministry of Energy, Commerce and Industry, in cooperation with the Cyprus - India Business Association are organizing an online event, aimed at the broad promotion of business relations between Cypriot and British-Indian companies, with regards to the professional services sector.

The event will be addressed by the Minister of Energy, Commerce and Industry Ms. Natasa Pilidou.

Each participating company from the Cypriot side will have a 5-minute slot to present to the British-Indian side. The topic to be presented will be discussed and confirmed at a later stage. Presentations will be followed by virtual B2B meetings between participating companies from the two sides in online private rooms.

The audience will consist of:

- Representatives of 12 companies from Cyprus.
- High level participants from the British-Indian business community that are interested in potential business cooperation with Cyprus.
