### **Business Delegation & Forum to Saudi Arabia** **10 – 14 January 2022**

**We are pleased to announce that the new dates of the Cyprus-Saudi Business Delegation are the 10-14 January 2022.**

The Cyprus Chamber of Commerce & Industry and the Ministry of Energy, Commerce, and Industry, with the support of the Cyprus – Saudi Arabia Business Association are organising a Business Delegation and Forum to Saudi Arabia (Riyadh, Jeddah) between 10-14 January 2022, aimed at the broad promotion of business relations between the business communities of Cyprus and Saudi Arabia.

**The Delegation will be headed by the Minister of Energy, Commerce and Industry Ms. Natasa Pilidou and the Deputy Minister of Research, Innovation and Digital Policy Mr Kyriacos Kokkinos.**
