Business Delegation & Forum to Saudi Arabia 10 – 14 January 2022

We are pleased to announce that the new dates of the Cyprus-Saudi Business Delegation are the 10-14 January 2022.

The Cyprus Chamber of Commerce & Industry and the Ministry of Energy, Commerce, and Industry, with the support of the Cyprus – Saudi Arabia Business Association are organising a Business Delegation and Forum to Saudi Arabia (Riyadh, Jeddah) between 10-14 January 2022, aimed at the broad promotion of business relations between the business communities of Cyprus and Saudi Arabia.

The Delegation will be headed by the Minister of Energy, Commerce and Industry Ms. Natasa Pilidou and the Deputy Minister of Research, Innovation and Digital Policy Mr Kyriacos Kokkinos.
