

Incoterms® 2020 contains the ICC rules for use of the 11 Incoterms® 2020 trade terms. It takes into account the latest development in commercial

practice and updates the rules to make them more accessible and easier to use.

The new rules entered into force on 01 January 2020. Traders are encouraged to make reference to the Incoterms® 2020 rules as the latest version of the trade terms.
